BACKGROUND INFORMATION: Nordstrom has purchased a Class C liquor license from Eldorado #1 located in Commerce Township and will amend the classification to a tavern license selling only beer and wine. The Police Department has completed their investigation and finds no reason to deny the request. The Fire Department and Building Department have no objection to approval within the proposed business location. The Planning Department has no objection, as the use is permitted in this zoning district, subject to site plan review.

8. What is the effect that the issuance of a license would have upon the economic development of the surrounding area?

BECAUSE THE CAFE BISTRO IS OWNED BY NORDSTROM, INC., IT WILL OFFER THE SAME LEVEL OF CUSTOMER SERVICE THAT IS THE FOUNDATION FOR ALL OF OUR STORES. WE BELIEVE THIS SERVICE, AS WELL AS THE QUALITY PRODUCTS WE OFFER, WILL BENEFIT THE COMMUNITY AND DRAW CUSTOMERS AND REVENUE TO THE TWELVE OAKS MALL.

9. What effect would the issuance of a license have on the health, welfare and safety of the general public?

NONE DETRIMENTALLY. THE NORDSTROM CAFE BISTRO SHOULD NOT BE VIEWED AS AN ESTABLISHMENT WHICH RELIES ON ALCOHOLIC SERVICE. ALCOHOL SALES ARE HISTORICALLY 3-4% OF TOTAL SALES. ALL NECESSARY EMPLOYEES GO THROUGH INTERNALLY-ESTABLISHED ALCOHOL TRAINING & ANY EXTERNAL GOVERNMENT-MANDATED TRAINING. IN THE UNPRECEDENTED OCCASION THAT A CUSTOMER BECOMES UNRULY, NORDSTROM HAS A STORE SECURITY DEPARTMENT WHICH WOULD INTERVENE.

10. Has the applicant received responses from the Police Department, Building Department and/or Fire Department with regard to the proposed facility?

YES. WE HAVE RECEIVED ALL NECESSARY PERMITS AND APPROVALS FROM ALL AGENCIES TO BUILD AT TWELVE OAKS MALL.

11. What is the public need or convenience for issuance of a liquor license for this facility at the proposed location?

IN ORDER TO PROVIDE NORDSTROM CUSTOMERS WITH A COMFORTABLE AND ENJOYABLE SHOPPING EXPERIENCE, THE NORDSTROM CAFE BISTRO OFFERS THEM THE OPTION OF COMPLEMENTING THEIR MEAIL WITH A GLASS OF BEER OR WINE. THE NORDSTROM CAFE BISTRO PROVIDES CONVENIENCE AND EASE FOR THE SHOPPER TO TAKE A BREAK FROM SHOPPING WHILE NEVER LEAVING THE STORE AND NEVER HAVING TO DRIVE.

12. What is the uniqueness of the proposed facility when contrasted against other existing or proposed facilities and the compatibility of the proposed facility to surrounding architecture and land use?

THE NORDSTROM CAFE BISTRO IS DISCREETLY LOCATED WITHIN THE NORDSTROM FASHION RETAIL STORE AND THEREFORE DOES NOT STAND OUT TO THE OUTSIDE GENERAL PUBLIC. IT BLENDS IN SEAMLESSLY WITH THE REST OF THE STORE AND MAINTAINS THAT SAME LEVEL OF DECOR AND SERVICE.

13. Does the facility to which the proposed liquor license is to be issued comply with the applicable building, plumbing, electrical and fire prevention codes and zoning statutes and ordinances applicable to the City of Novi? Has applicant received information from the appropriate departments?

YES AND YES.

14. What effect will the facility to which to which the proposed liquor license is to be issued have upon vehicular and pedestrian traffic in the area?

NONE. THE NORDSTROM CAFE BISTRO IS SITUATED WITHIN THE NORDSTROM FASHION SPECIALTY RETAIL STORE.

15. What is the proximity of the proposed business facility to other similarly situated licensed liquor facilities?

THE NORDSTROM CAFE BISTRO IS LOCATED WITHIN NORDSTROM AND THE TWELVE OAKS MALL WHICH HOUSES NUMEROUS ESTABLISHMENTS WHICH OFFER ALCOHOL.

16. What is the proximity of the proposed facility to complimentary uses such as office and commercial development?

THE NORDSTROM CAFE BISTRO IS LOCATED WITHIN NORDSTROM THE FASHION SPECIALTY RETAIL STORE AS WELL AS THE TWELVE OAKS MALL WHICH IS COMPRISED OF COMMERICAL DEVELOPMENT AND STORES.

17. What effect would the proposed facility have upon the surrounding neighborhood and/or business establishments, including impacts upon residential areas, church and school districts?

NONE.

18. What proposed or actual commitments are being made by the applicant to establish permanency in the community?

THE NORDSTROM CAFE BISTRO IS WITHIN NORDSTROM WHICH IS BEING NEWLY CONSTRUCTED - AND IS PERMANENT - AS AN EXPANSION OF THE EXISTING TWELVE OAKS MALL.

19. What utilities are available to serve the facility?

ALL NECESSARY UTILITIES TO FULLY OPERATE A RESTAURANT ARE AVAILABLE. ADDITIONAL UTILITIES AND SERVICES ARE PROVIDED BY THE REST OF THE NORDSTROM STORE.

20. What other factors should the Novi City Council consider?

ALCOHOL SALES PERCENTAGES AT OTHER NORDSTROM RESTAURANTS THROUGHOUT THE COUNTRY ARE ESTIMATED AT 4% OF TOTAL SALES. THE SAME IS EXPECTED FOR THE NORDSTROM CAFE BISTRO IN NOVI. THIS CLEARLY ILLUSTRATES THAT ALCOHOLIC SERVICE IS NOT A DOMINANT FACTOR BUT RATHER, A WAY TO SERVE THOSE CUSTOMERS WHO CHOOSE TO ADD IT TO THEIR EXPERIENCE AT THE RESTAURANT.

AMENDED AND RESTATED ARTICLES OF INCORPORATION OF NORDSTROM, INC.

Pursuant to the provisions of the Washington Business Corporation Act and RCW 23B.10.020 and RCW 23B.10.070, the following Amended and Restated Articles of Incorporation are hereby submitted for filing.

ARTICLE I

The name of the corporation is Nordstrom, Inc.

ARTICLE II

The period of duration of the corporation is perpetual.



ARTICLE III

The purpose of the corporation is to engage in any and all business, the conduct of which is not forbidden to corporations by the Constitution, statutes or common law of the state of Washington.

ARTICLE IV

- 1. The aggregate number of shares which the Corporation shall have authority to issue is 1,000,000,000 shares of Common Stock, all of which are without par value.
- 2. The shareholders of the corporation shall not have preemptive rights to acquire additional shares or securities convertible into shares offered for sale or otherwise issued by the corporation.
- 3. No shareholder will be permitted to cumulate his votes at any election of directors.

ARTICLE V

The number of directors constituting the Board of Directors shall be such number, not less than three, as may be specified from time to time in the Bylaws.

ARTICLE VI

The corporation shall have the right to purchase its own shares to the extent of unreserved and unrestricted surplus available therefor, whether capital surplus or earned surplus. The Board of Directors may, from time to time, distribute to the shareholders a portion of the assets of this corporation, in cash or property, out of the capital surplus of this corporation.

The power to adopt, alter, amend or repeal the Bylaws shall be vested in the Board of Directors.

ARTICLE VIII

ARTICLE IX

If hereafter the Washington Business Corporation Act is amended to change the corporation's power to eliminate or limit the liability of a director to the corporation, then, upon the effective date of the amendment and without further act:

if the amendment permits further elimination or limitation of liability, the liability of a director shall be additionally eliminated and limited to such further extent, or

if the amendment changes to power to eliminate the liability of a director in any other respect, the liability of a director shall be eliminated and limited with respect to acts or omissions occurring after the effective date of the amendment to the fullest extent permitted by the Washington Business Corporation Act as so amended.

No amendment or repeal of these Amended and Restated Articles of Incorporation shall adversely affect any right or any elimination or limitation of liability of a director existing immediately prior to the amendment or repeal.



Nordstrom, Inc. plans to purchase and transfer a Class C liquor license with an official permit for extended hours of operation. The classification of the license will be amended to a Tavern license since the Nordstrom Café Bistro will sell only beer and wine. At this time Nordstrom does not own a license.
