SUBJECT: Approval of MERS Resolutions to Exclude Temporary Employees from Membership, to Define a Day of Work for Administrative (General Non-Union) and Teamster employees

CITY MANAGER APPROVALE

The City of Novi has had a policy of excluding temporary and part-time employees from certain benefits, including pension benefits.

MERS requires the City Council to adopt a formal policy regarding the exclusion of these benefits, and these resolutions are attached and recommended for approval. These resolutions are consistent with the City's past practice.

Without the adoption of this resolution all temporary employees would be eligible for MERS pension benefits if they work 80 hours in a month or 75 hours in a month for 8.0 schedule employees or 7.5 hour schedule employees, respectively.

RESOLUTION TO EXCLUDE TEMPORARY EMPLOYEES FROM MEMBERSHIP IN MERS UNDER PLAN DOCUMENT SECTION 3(2)

TEMPORARY EMPLOYEES who are employed in positions normally requiring less than 6 or more whole months, not to exceed 12 months of work may be excluded by Resolution of the Governing Body from membership in the Municipal Employees' Retirement System (MERS). Temporary employees must be notified in writing by the participating municipality that they are excluded from membership. In accordance with Section 3(2) of the MERS Plan Document, the
