BACKGROUND INFORMATION:

Each year the City considers the capital improvements as recommended by Suburban Management. For the 2007-2008 fiscal year, Suburban recommended replacing the upper-level carpet with rubber flooring, and City staff concur with their recommendation. Measurements indicate that the rubber flooring will cover 5,500 sq. ft. of the complex and have a useful life of approximately 15 years, as compared to the existing carpet that must be replaced every 6-8 years. Installation of rubber flooring decreases overall maintenance costs and doubles the life expectancy over the current flooring product.

In October 2007 proposals were received for upper level rubber flooring. Upon a thorough investigation the department found Master Craft Carpet Services Inc. best meets the City's requirements for this project. Upon awarding the bid, the material will be delivered to the arena in six weeks and installed by January 2008.
