#### BACKGROUND INFORMATION:

The Novi City Council appropriated \$21,690 for phase II of the removal and replacement of exterior caulk at the Novi Civic Center. The existing material has exceeded its useful life and shows separation points between the glass panels and their metal frames.

In September 2007, five bids were received for atrium caulking phase II. Upon a thorough investigation, the department found Western Waterproofing Company best meets the City's requirements for this project. Upon award, work will begin this fall and be completed by November 15, 2007.

**DATE:** 10/11/07

Over the past several year's maintenance staff has identified points in the atrium glass and metal framing that are no longer sealed with a protective layer of caulk. In the 2006-2007 fiscal year the Novi City Council allocated funds for phase I of a multi phase project that would secure glass and metal joints throughout the complex. The initial phase removed all of the old caulking and re-sealed atrium ceiling glass to its metal framing, and was completed in the fall of 2006.

In the 2007-2008 fiscal year \$21,690 was allocated by the Novi City Council for phase II of the project. This current phase removes all of the existing caulk from the curtain windows and frames and replaces it with a product that carries a 20 year life rating. It also removes and replaces hallway window caulking that surrounds the event quarters. In January of 2008 phase III will be requested, completing caulking of all aluminum panels located around the penthouse.

In September 2007 five bids were accepted for atrium caulking phase II. Upon a thorough investigation the department found Western Waterproofing Company best meets the cities requirements for this project. If awarded work will begin this fall and be completed by November 15, 2007.

# Atrium Window Caulking Phase II Addendum #1

#### INTENT:

This addendum has been issued to modify and/or interpret the specifications for the Atrium Window Caulking Phase II bid. Unless otherwise instructed, the information contained in this Addendum shall take precedence over anything contrary in the original specifications and shall hereinafter be considered as part of the package.

**RESPONSE:** The contractor shall verify receipt of this Addendum in the Bid Proposal Form.

**CONTENTS:** Included in this addendum is one (1) page of written addenda description. No drawings are included.

#### **CLARIFICATION:**

1. Question: We are NOT to caulk the metal to metal joints?

Answer: Caulk metal to metal joints, except weep holes.

2. Question: The drawing detail 4 on A-12 does not show the height of the skylight window. Can you please provide this information.

Answer: The pane of glass is 7'4" long x 31" wide. The skylights are triangular in shape. The highest point of the frame to the ground is 54". The lowest point from the frame to the ground is 2'. Skylight area #1 is 59' long. Skylight area #2 is 66' 8" long. Skylight area #3 is 66' 7" long.

 Question: I understand that the top of the atrium is not to get caulked, however, are the following sloped panels to get caulked?
 A-10 North Elevation – column lines 9-6.5.
 A-10 East Elevation – column lines D-F.5

Answer: Atrium top and slopes were caulked. Only the vertical wall glass is to be caulked.
