BACKGROUND INFORMATION:

The Novi City Council appropriated \$21,150 in the 2007-2008 fiscal year for the purchase of a topdressing machine to be utilized in the parks system. This vehicle implement assists with routine maintenance on baseball and soccer fields, enhancing general turf quality throughout the athletic season. The Banner BTD-20 allows City staff to add metered amounts of infield material, compost, soil, loose stone, or sand on pathways, skinned infields, and stone roadways at regular intervals. This machine allows the department to enhance athletic field standards and increase the overall safety for our user groups.

In September 2007 bids were received for the topdressing machine purchase. Upon a thorough investigation, the department found Turf Services Inc., the lowest qualified bidder; best meets the City's requirements by providing the Bannerman BTD-20 topdresser within the amount allocated. In previous fiscal years the recommended vendor has successfully completed Community Sports Park Field #5 Renovation and Power Park Infield Resurfacing.

The Novi City Council appropriated \$21,150 in the 2007-2008 fiscal year for the purchase of a topdressing machine to be utilized in the parks system. This vehicle implement assists with routine maintenance on baseball and soccer fields, enhancing general turf quality throughout the athletic season. The Banner BTD-20 allows city staff to add metered amounts of infield material, compost, soil, loose stone, or sand on pathways, skinned infields, and stone roadways at regular intervals. This machine allows the department to enhance athletic field standards and increase the overall safety for our user groups.

The BTD-20 allows field service staff to efficiently fill in holes that have been created on athletic fields and transport large amounts of material over grassy surfaces limiting the amount of compaction to the soil below. It is estimated that this machine can topdress one soccer field with ½ inch of material in two hours. Previously it would take two staff members eight hours per field with a truck, rake and shovel.

In September 2007 bids were accepted for the Topdressing machine purchase. Upon a thorough investigation the department found Turf Services Inc. best meets the cities topdresser requirements by providing the Bannerman BTD-20 with-in the amount allocated. In previous fiscal years the vendor has successfully completed the Community Sports Park Field #5 Renovation and Power Park Infield Resurfacing.
