BACKGROUND INFORMATION:

The proposed program year (PY) 2009 planning allocation for the City of Novi is estimated to total \$111,900. The previous history, 2009 Agency requests, HCD Committee recommendation, and final staff funding recommendation for 2009 are as follows:

The financial impact of this recommendation would result in an additional \$15,000 transfer from the City's General Fund to the Parks, Recreation & Forestry Fund (for the Senior Transportation Program) as compared to the prior year. There would be no change in the program delivery.

* The maximum 45% allowed within the Public Service category for 2009 is \$50,355

2008 Final Staff Funding Recommendation: The recommendation to restore HCD funding for the senior van transportation program in 2009 is based on several considerations. Novi currently provides for the transportation needs of its seniors and persons with disabilities using a combination of a municipal van service operated directly through our senior center and a

subsidized taxi program, 11,615 rides were provided by this system in FY 2007-08. The City of Novi receives funds of approximately \$44,713 a year from the SMART Municipal Credit Program to support transportation services within Novi. Approximately \$20,000 of these monies is used to offset the cost of the taxi program and the balance of funds of approximately \$24,713 is then applied to the van program. Community Development Block Grant (CDBG) funds are used to offset the cost of senior van drivers with the balance of funding for transportation coming directly from user fees and a General Fund subsidy. For the fiscal year ended June 30, 2008, this subsidy has approached nearly \$55,000 and has doubled from 2002 primarily due to increased fuel costs and the increased demand for this program. This subsidy only reflects direct operating costs and does not include other various indirect costs such as liability insurance, administrative costs and depreciation to fund future replacement vehicles. Moreover, in the previous grant year, the HCD funding assistance for a senior center manager was removed and transferred to the General Fund (keeping same service level). A reduction in CDBG funding for 2009 would only increase this subsidy even further when planning for the fiscal year 2009 – 2010 budget and therefore is not recommended at this time.

HAVEN requested funding for 2009 in the amount of \$9,500 and it is not recommended to increase funding beyond their request. The Novi Youth Assistance Program has been maintained at the current 2008 program level of \$11,000. In addition to funds received from CDBG, the Novi Parks & Recreation Foundation provides funds for scholarships and camp programs which can be used by Novi residents as well. Based on these recommendations, the funding for the Minor Home Repair Program would total \$66,400. This amount will keep the program level consistent with 2008 and prior years.

A resolution with the final 2009 CDBG recommendations has been attached.

RECOMMENDED ACTION: Approve the Program Year 2009 Community Development Block Grant Application in the approximate amount of \$111,900 and authorize the Mayor to sign the Application and Sub-recipient Agreement.

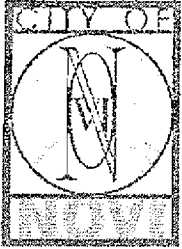

Date: October 9, 2008

The proposed program year (PY) 2009 planning allocation for the City of Novi is estimated to total \$111,900. While Oakland County has not received confirmation from the U.S. Department of Housing and Urban Development (HUD) on exact funding levels for PY 2009, the County is instructing participating communities to assume little change from their current PY 2008 funding levels at this time.

Funding requests were reviewed by the Housing and Community Development Advisory Committee at their meeting of October 2nd and they are recommending the following program allocations:

The financial impact on this recommendation would result in an additional \$15,000 transfer from the City's General Fund to the Parks, Recreation & Forestry Fund (for the Senior Transportation Program) as compared to the prior year.

Letters requesting grant funding from HAVEN, Novi Youth Assistance and the Senior Van Program have been included within this packet as additional information.

Program Year 2009 Public Service Cap. Oakland County is required by HUD to maintain an overall public service cap of 15%. Since November 1, 1996, Oakland County has allowed participating communities to spend a maximum of 50% of its annual allocation for public service activities and still maintain the overall 15% requirement. This has been possible because of the large offsetting Oakland County Home Improvement Program. The impact of the 2000 census was to eliminate the area wide benefit activities for many communities forcing more communities to now allocate funds directly to public service activities. **As a result, Oakland County will only allow participating communities to spend a maximum of 45% of their annual allocation on public services.** The public service category has allowed the City of Novi to fund programs and services such as senior transportation, senior manager, Youth Assistance and HAVEN.

As a result of this action by Oakland County, the maximum amount the City of Novi is allowed to allocate to the public service program category for 2009 is \$50,355 ($\$111,900 * 45\%$), assuming our estimated grant award remains at \$111,900. Funding requests for public service activities were received for 2009 totaling \$49,500.

HCD Committee Recommendation. At the Committee meeting held October 2nd, representatives from the various outside agencies requesting funding from Novi's CDBG program were present to answer any questions the HCD Members had with respect to their request for funds. Based on the presentation by the Novi Youth Assistance (NYA) represented by Claudia Walter, John O'Brien and Kim Ziegler, the Committee agreed to recommend continued funding for Youth Assistance at their requested funding level of \$15,000. Funding dollars allocated to NYA are used to provide direct intervention services for Novi youth and include counseling, enrichment, skill building and academic support to children who are for various reasons deemed to be at "at risk" or whose families have insufficient financial resources to meet their needs for these activities. The broad goals are: 1) to provide scholarships to allow children (who qualify by income) to attend various summer camps according to their individual interest and needs, 2) to enroll qualifying children in programs that increase skills in various areas and 3) to provide tutoring to qualifying children who can benefit from additional academic support. The \$4,000 increase in funding levels from last year reflects the increase in demand for these services given the current economic conditions many families are facing within our community.

Our city-wide Minor Home Repair program has experienced tremendous success in past years. Last year we reported to Council a drop in client demand from prior years. As a result, the Committee embarked on an outreach effort to increase awareness for the program among our residents. Letters along with a list of Minor Home Repair Program Guidelines were developed and mailed to our local church leadership as well as face-to-face meetings to answer any questions. Additional outreach efforts included articles in the Novi News, City web-site enhancements as well as application drives conducted by the Oakland County Human Service Agency (OLHSA). Because of these outreach efforts the demand for Minor Home Repair has now increased beyond our current funding levels. All of the 2008 program year funds have now been obligated and we have started a waiting list for the 2009 program year. Because the Committee feels this program is so vital to our residents in terms of meeting the immediate health and safety needs of Novi families, they have recommended reducing the allocation for the Senior Van Transportation Program by \$15,000 and instead reallocate the majority of this funding to the Minor Home Repair Program for a total allocation of \$76,900. If this action is approved, the recommendation would result in an additional \$15,000 transfer from the General Fund to the Parks, Recreation & Forestry Fund in fiscal year 2009-10 as compared to the 2008-9 fiscal year. ***The Committee is further recommending that any funding cuts in 2009 be offset directly against the \$10,000 allocation being recommended for the Senior Van Transportation Program.***

HAVEN Guidelines for CDBG Communities. Beginning with the 2007 Program Year, Oakland County now contracts directly with HAVEN as a sole source provider on behalf of participating communities. In the past, each community would contract individually with HAVEN. The contract duration period will be one year and at the end of the contract period, any community balance will be expended for the 24-hour crisis hotline. HAVEN has requested funding for 2009 in the amount of \$9,500. Present at the meeting was Belle Kleinberg on behalf of HAVEN who reported last fiscal year a total of 369 Novi residents received direct assistance from HAVEN by way of shelter assistance, crisis intervention as well as services from HAVEN's Personal Protection Order Office. Of the 369 Novi residents using the program, CDBG funds in the amount of \$9,232 were used last year to provide assistance to 82 individuals. The Committee is recommending continued funding for HAVEN at a program level of \$10,000 for 2009.

Neighborhood Stabilization Funds – Emergency Assistance for the Redevelopment of Abandoned and Foreclosed Homes - P.L. 110-289, Housing and Economic Recovery Act of 2008 (H.R. 3221), Title III. The Housing and Economic Recovery Act of 2008 appropriates \$3.92 billion in Community Development Block Grant (CDBG) funds to States and localities for the redevelopment of abandoned and foreclosed homes. Oakland County expects to receive \$17 million in Neighborhood Stabilization Program (NSP) funds. The County is currently in the process of determining how these funds will be distributed to local communities, if at all. A quick overview of some of the program guidelines include:

Eligible Uses of Funds –

- ✓ Purchase and rehabilitate abandoned and foreclosed properties to sell, rent or redevelop.
- ✓ Establish financing mechanisms for purchase and redevelopment of foreclosed homes.
- ✓ Establish land banks of foreclosed homes.
- ✓ Demolish blighted structures.
- ✓ Redevelop demolished or vacant properties.

Targeting of Funds –

- ✓ Funds must be used to benefit households whose incomes do not exceed 120% of area median income. At least 25% of the funds must be used to purchase and redevelop housing for households whose incomes do not exceed 50% of area median income.
- ✓ Funds must be targeted to areas with the greatest percentage of home foreclosures and with the highest percentage of homes financed by a subprime mortgage-related loan.

Implementation and Timeframe –

- ✓ Urban County/Entitlement jurisdictions must submit applications/plans to HUD by December 1, 2008.
- ✓ Funds must be obligated within 18 months of funding release.

2000 Census Impact. Enclosed with this packet is the 2000 census areawide benefit map. A comparison to the 1990 map shows census tract 1361, block group 2 which includes Lakeshore Park, no longer qualifies for CDBG funding of infrastructure type projects. The Recommended Projects for 2009 do not include any area benefit type projects such as parks, streets or sidewalk improvements. The projects are strictly city-wide individual income-qualified type projects such as minor home repair or direct benefit projects such as public services which are not dependent on census tract location.

Dear Committee Members:

Novi Youth Assistance has received and utilized CDBG funding for moderate, low income and special needs youth since 1994. With continuing community support we have consistently honed our ability to identify at risk children who would benefit from recreational, educational and supportive programming. Once again this year, overall grant opportunities were reduced. In spite of this, we still insured a summer recreation program for Novi children at our own expense. Nonetheless, this along with a significant increase in requests for services has regrettably left us struggling, once again, to assist all applicants. As the sole local organization that can regularly provide comprehensive and varied scholarship opportunities within the City of Novi, we continue to find that demand is outpacing donations received. In fact, need has increased so significantly that as of June 2008 all funds were already dedicated and, for the first time ever, we have had to deny all new requests. While we have made internal adjustments to stretch our monies as best we can, continued and increased CDBG funding is vital if we are to continue providing programming in 2009-2010 to those who otherwise might go unserved.


Most notable as we have moved through this past year, is the ever increasing number of residents who are struggling to provide the basics for their families. This then, inevitably eliminates any options to offer their children positive, healthy activities. Many of these children are then left with unscheduled time which leaves them at risk which, in turn, affects the community as a whole.

Historically, Novi Youth Assistance has been there to provide for those in need when there have been no other options. We continue to strive to do so. The benefit of offering summer programs, skill building activities and other supportive programming is demonstrated over and over again as we see these children move through the schools and community successfully. Therefore, in response to today's economic climate and rising costs, as well as demand for programming and decrease in other funding, Novi Youth Assistance respectfully requests that the members of the CDBG committee consider granting funds for the 2009 budget year in the amount of \$15,000.00.

Dear Novi Youth Assistance,

I never would have believed how much a city funded program could impact my life prior to utilizing your program. I would not have believed the skills and coping techniques I learned could be taught at your program, and most certainly, I would have never believed that a city funded program could contain such a supportive and caring staff. Your program reversed my misconceptions and helped me become a more productive citizen and a happier person.

I first started the program when I was 12 years old, using Novi Youth Assistance as a way to receive counseling for growing social and family problems I was facing. Because it was offered for free, my parents were able to get me help that they would not have been able to otherwise afford. Your staff helped me identify panic attacks I was having and how to deal with the anxiety that kept increasing exponentially in my daily life. I've used the methods I've learned ever since, and they continue to help me act as a better individual in society. Your staff also helped me deal with my father's verbal abuse, counseling me through ways to better handle being around him and helping me understand that it wasn't my fault for what was happening. As a young adolescent, that was instrumental in ensuring that I grow into a mature and fully developed adult. Thank you for your guidance during my times of stress. I wish I could say I don't know what would have happened to me without your program, but sadly I do.

Following my parent's divorce when I was 14 years old the program recommended that I see a divorce therapist to help me deal with the challenges children face during a divorce. I bounced around from plenty of different therapists and psychiatrists, but was unsuccessful finding anyone that was as great as your staff is. I eventually turned to drugs to help ease my problems and from there I plunged into darkness, my relationship with my parents virtually deteriorated, my grades went from A's to C's then even D's and F's, and finally I hit rock bottom by getting arrested twice within 4 months. I wish I had stayed with your recommendation of a therapist, for I believe it may have saved me. Either way, without the program I travelled down a very dark road of my life.

After cleaning up, coming back to the program was quite successful in helping me maintain a clean and sober lifestyle, and your program helped pull me out of the darkness I was stuck in. Again, your staff taught me coping skills for stress and helped me get on track to being a productive citizen in society. Thank you for helping me stay on track, and for helping me out once again.

Talking with some of my friends who have also been in the program, we are all in agreement as to how vital your service is to the community, and most definitely how vital it was for us as people. My gratitude for the work of your staff cannot be expressed in words, nor can it be measured in any way possible. Thank you for all that you've helped me overcome and achieve.

Thanks to Novi Youth Assistance, I'm on my way to being a happier, more productive, and more informed citizen in our world.




Violence in families is everywhere, crossing racial, ethnic, cultural, social and economic boundaries. The impact of this violence invades our schools, places of worship, offices, businesses, and factories throughout our neighborhoods. Human beings, both young and old, are being harmed physically, sexually and emotionally and this violence may be creating lifelong patterns of ongoing abuse in youngsters as they move into adulthood. We all pay the cost for the horrible crimes of domestic violence and sexual assault either in real dollars or in diminished potential of human and community life.

Since 1982, HAVEN has been dedicated to building violence-free communities one family at a time. HAVEN maintains a 24-hour emergency shelter exclusively for domestic violence victims and their children and sexual assault survivors who are afraid to stay in their own homes. HAVEN offers counseling and education that help families stop the violence, begin the process of healing, and create the hope that their future will be free from abuse. The agency steps out into the community – over the phone, in courtrooms, police stations, hospitals, schools, the work place, and at community meetings – to provide crisis intervention and education to help victims and families prevent violence in future generations. HAVEN staff manages the Personal Protection Order office located in the Circuit Court system, helping create and file Personal Protective Orders at no charge to the victims of abuse as the first step in their safety plan.

HAVEN through its comprehensive work, serves to break the silence that has kept the crimes of domestic violence and sexual assault behind closed doors. This silence has only served to allow these crimes to flourish. From July 1, 2007 through June 30 2008, 265 individuals were seen, 52 crisis calls were received and 52 accessed the services of our Personal Protection order office from families in the City of Novi who took the first step to break their own silence by contacting HAVEN. The agency is again reaching out of you for support of our work with an even greater need as we assume the additional burden of increased clientele and additional staff to maintain these vital services. We ask that you continue to support these families through a Community Development Block Grant of \$9,500.00 for fiscal year 2009-2010. Please remember that the federal government presumes that domestic violence victims are considered to be low income and therefore qualify for inclusion in block grant public service requests.

HAVEN looks forward to the opportunity to meet with you this year to provide further information on this request and answer any questions you may have. In the meantime, if you wish to speak with me, I can be reached at (248) 334-1284 ext. 240. Thank you.

BACKGROUND

The Novi Senior Transit program began in February 1990 with one van funded by The Independence for Life Association and one part-time driver funded by Novi Parks and Recreation. The first full year of operation, we provided a surprising 3390 one-way rides. It soon became apparent that as residents discovered this essential new service, the demand would increase dramatically. In the past five years, we have provided 54,953 one way rides.

City of Novi General Fund, CDBG, and SMART Municipal Credits funding have supported the program throughout its existence by providing vehicles as well as funding for operations.

CURRENT PROGRAM

The Senior Transit program currently operates a total of 7 vehicles:

Our transportation department employees include 3 part-time driver/schedulers and 11 part-time drivers.

The transportation program operates Monday, Wednesday and Friday from 8:00-9 pm, Tuesday and Thursday 8:00 - 4:30 pm and Saturday 9 - 2. Passengers may ride anywhere within the City of Novi for a nominal fee of \$3 per one-way ride and \$5 per one-way ride for up to 10 miles outside the city of Novi for medical appointments only. We have created a "punch card" for our passengers that allow them to purchase a card for \$30.00 which allows six one-way rides or six one way rides out of town. This card is used in place of cash, makes it easier for the passengers and ensures us of collecting fees. Transportation is provided to Novi residents only. Riders must be age 55 plus, or physically challenged of any age. We encourage residents to call 48 hours in advance by calling the Scheduler at (248) 735-5617.

NOTE: The City of Novi also subsidizes a demand-response type of transportation service via Community Cab. Riders must also be seniors or physically/mentally challenged non-senior residents of the City of Novi and will pay \$4 per one-way ride within the City limits. Regular rates apply outside the City. Reservations may be made by calling (248) 349-8118.

We continue to provide a safe and trustworthy senior transportation program to the senior population in Novi. For 2007/2008 we provided 11,615 one way rides for seniors and physically/mentally challenged non-seniors, collected \$17,809 in fares and provided 3,881 cab rides with our cab service. The numbers alone show how important this program is to our older adult community.

FUTURE OF THE PROGRAM

In as much as there is no other public transportation in the City of Novi other than cab service and our Transit system, continued population growth, particularly in the age 65 plus group, create increased demands for transportation service. Numbers will continue to increase due to more and more seniors in our community relying on us to take them to their destination. Safety and health issues along with mobility problems with our older adults are a factor when they can no longer drive and can not find a way to medical appointments or to the drug store to get prescriptions show us this is becoming a bigger problem in our community. Our numbers are also increasing with passengers from other senior housing because they either do not offer any transportation and if they do, charge a higher fee or only have limited capabilities to transport to limited areas only. In addition, there are increasing numbers of non-senior Novi residents who, for health reasons, do not have transportation.

The cost of the transportation program continues to grow rapidly. In 2006/2007, cost of the program was \$124,682. With the increase of gasoline, maintenance and number of people using our service, the cost for the 2007/2008 program rose to \$140,651. We anticipate the cost exceeding this amount for 2008/2009. We would like to continue to receive the monies from the CDBG funding to help support this worthwhile program.

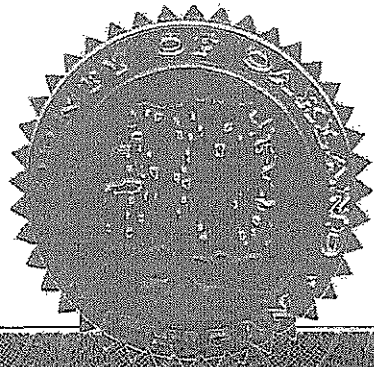

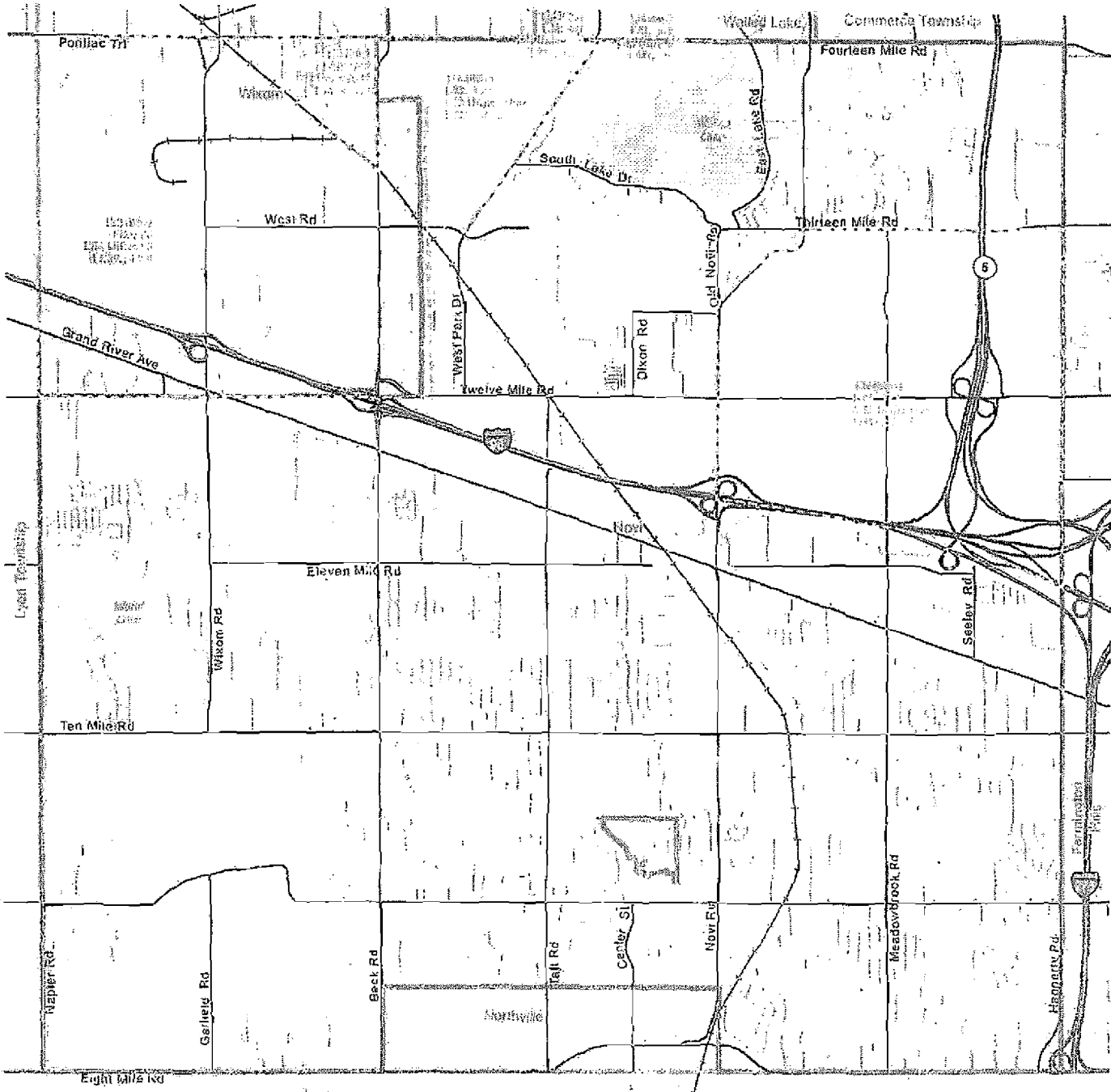
