SUBJECT: Approval to purchase one (1) 2012 Ford Expedition 4x4 EL Special Service Vehicle through the Macomb County Cooperative Bid Program from Signature Ford, in the amount of \$32,060.

BACKGROUND INFORMATION:

As part of the FY 2011-12 budget process, forfeiture funds were approved to purchase one (1) replacement SUV type marked patrol vehicle. This specialty vehicle is for the exclusive use of the on duty uniform patrol supervisor. The current Expedition has 67,922 miles and per the Collective Bargaining Agreement all patrol vehicles must be retired after 80,000 miles. At the request of the administration, the Command Officer's Association of Michigan (COAM) has agreed to extend the mileage on this vehicle to 90,000. By proceeding with the purchase, at this time, the 2012 pricing will be locked in through December 28, 2011 and there will be no risk of a price increase before the order is placed.

The Department is pleased with the performance of the two 2009 Expeditions in its fleet. The Expedition is the preferred vehicle based on their durability and effectiveness in bad weather. The supervisory vehicle is loaded with numerous pieces of equipment used in emergency situations and is prepared to act as a temporary command post during rapid response incidents. Day-to-day supplies are also on hand to supplement the normal equipment that is placed in each patrol unit. Included in these supplies are the heavy raid bullet-proof vests with additional raid entry tools, additional traffic cones, flares and batteries to be deployed as needed.

Upon removal of the vehicle from service, it will be transferred to the Fire Department to pull rescue boats and assigned to Station #2. The Expedition will replace the white, 1997 Chevrolet S-10 pickup truck that is currently in the Fire Department fleet. This truck has 35,937 miles and is inadequate for towing of the rescue boats.
