SUBJECT: Park Naming Options for 13 Mile and Old Novi Road (Landings).

SUBMITTING DEPARTMENT: Parks, Recreation and Cultural Services

CITY MANAGER APPROVAL

#### BACKGROUND INFORMATION:

Between January 23rd and February 17th, the PRCS Department solicited ideas for a new name for the 13 Mile and Old Novi Road Park Property (Landings). Citizens submitted naming suggestions via email at parknaming@cityofnovi.org or in person with a provided form which was available at the Parks office and online at cityofnovi.org. Seventy seven (77) different names were suggested by citizens. A park naming committee was assembled and picked the top names to send to City Council. Committee members included Charlie Staab, Butch Wingfield and Matt Tecklenburg from the PRCS Commission, John MacInnis, and Roy Prentice from the Historical Commission, Sarah Rachiele a 5th grade student from Hickory Woods Elementary School, the Levy Family who reside near the park and senior citizen, and longtime Novi resident Ernie Aruffo.

During discussions the Park Naming Committee felt that incorporating the history of the park in the name was the most significant factor in the name. The top three name suggestions are:

- Casino Point (or Casino Shores) Park Suggested for the old Walled Lake
  Casino adding 'point' due to the design of the park which features a
  prominent 'point' that extends into the lake (adding 'shores' is an alternative
  due to the parks location on the shores of the lake).
- Potawatomi Park Suggested for the native people who once inhabited the area – the Potawatomi Tribe.
- Pavilion Shore Park Suggested for the pavilion that stood at this location for summer recreation, dancing and band performances during the 20's, 30's, 40's, and 50's.

Assuming that the name is changed, the old signage designating the property as Landings Park will be removed and a press release will be issued upon City Council selecting the new name for the park. New signage will be installed on the site as part of the park construction process this year.

**RECOMMENDED ACTION:** Recommend park name for the park located at 13 Mile and Old Novi Road, formerly known as The Landings.

Between January 23<sup>rd</sup> and February 17<sup>th</sup>, the PRCS Department solicited ideas for a new name for the 13 Mile and Old Novi Road Park Property (Landings). Citizens could submit naming suggestions via email at parknaming@cityofnovi.org or in person with a provided form which was available at the Parks office and online at cityofnovi.org. Seventy-seven (77) different names were suggested by citizens and a park naming committee was assembled and picked the top names to send to City Council. The comprehensive list of submitted names is enclosed. Committee members included Charlie Staab, Butch Wingfield and Matt Tecklenburg from the PRCS Commission, John Macinnis, and Roy Prentice from the Historical Commission, Sarah Rachiele a 5<sup>th</sup> grade student from Hickory Woods Elementary School, the Levy Family who reside near the park and senior citizen, and longtime Novi resident Ernie Arruffo.

During discussions the Park Naming Committee felt that incorporating the history of the park in the name was the most significant factor in the name. The top three name suggestions to be presented at the March 12<sup>th</sup> City Council Meeting are:

- Casino Point (or Casino Shores) Park Suggested for the old Walled Lake Casino adding 'point' due to the design of the park which features a prominent 'point' that extends into the lake (adding 'shores' is an alternative due to the parks location on the shores of the lake).
- Potawatomi Park Suggested for the native people who once inhabited the area – the Potawatomi Tribe.
- **Pavilion Shore Park** Suggested for the pavilion that stood at this location for summer recreation, dancing and band performances during the 20's, 30's, 40's, and 50's.

The old signage designating the property as Landings Park will be removed and a press release will be issued upon City Council selecting the new name for the park. New signage will be installed on the site as part of the park construction process.

	Park Naming Suggestion	Justification
1	Algonquin Park	The Ottawa Indians lived in the area. Algonquin and Pottawattomies were members of the Ottawa Indians. Source: The Story of a Village Community
2	Bowlder Park (yes with a "w")	There is a five feet wide and four feet tall glacier wall in Walled Lake formed by the glacial period. During a large part of the glacier period, southeastern Michigan lay beneath hundreds, if not thousands, of feet of ice. Over much of the area a thick deposit of bowlder clay accumulated. Lakes and ponds were formed by the melting ice of the glacier. Some believed that this wall was man-made, but geologist have proven this not to be true. Source: The Story of a Village Community
3	Casino Cove	Remembering the Walled Lake Casino, which was located at this site.
4	Casino Gardens	The connection to the famous casino that once stood there.
5	Casino Landing	The connection to the famous casino that once stood there.
6	Casino Point Park	Casino for the Walled Lake Casino - Point because of the features in the design which create a point that extend out over the water.
7	Casino Shores Park	History or historic significance to the area.
8	Casino Shores Park	Casino Shores was the name of the first casino/ballroom built on the site in 1925. It reflects the history of the former casino and its location on the shore of Walled Lake.

**DATE:** JANUARY 25, 2012

At the January 9, 2012 City Council meeting, the outline for naming the park at 13 Mile and Old Novī Road (Landings Property) was presented and discussed. Since that meeting, the Parks, Recreation and Cultural Services Department has begun the process to solicit potential park names and have begun assembling community members to serve on the park naming committee. The Committee will consist of 3 members of the PRCS Commission, two members of the Historical Commission, two local youth and one senior resident. The Parks Commission selected Charlie Staab, Butch Wingfield and Matt Tecklenburg at their January 12th meeting. The Historical Commission meets on Wednesday, January 25th and will select their representatives at that time. Youth delegates will be Hickory Woods 5th grade students as selected by principal, Dr. Pat Warner. Longtime Novi Resident and community advocate, Ernie Arrufo has been asked to be our senior representative.

Both the Novi News and the Novi Patch are working with the department to inform the public about the project and both have run stories in their respective publications. The department will also send out additional press releases beginning the week of January 23<sup>rd</sup>. An email address, <u>parknaming@cityofnovi.org</u> has been set up and suggestions have come in daily at that address. Citizens can provide their suggestions via email, or in person with the attached form.

Suggestions will be received until, Friday, February 17, 2012. The park naming committee will receive all suggestions at that time and narrow choices down to the top 3-5 names to present to City Council. It is anticipated that City Council will choose a name at the March12,2012 City Council meeting.

SUBMITTING DEPARTMENT: Department of Parks, Recreation and Cultural Services

CITY MANAGER APPROVAL

BACKGROUND INFORMATION:

The majority of the Landings park property was acquired by the City in the 1980's and was designated as parkland on March 22, 2010. The "Landings" name comes from a proposed development that at one time was planned to go in at that site. The current name does not necessarily reflect the rich and unique history of the property and other names should be considered as the process goes forward to get this public space into use.

In 2005 the Novi City Council adopted the Parks and Recreation Facilities Naming Rights Policy, which provides the authorization for an individual, family, private business or corporation to purchase the right to name a fixed asset. The policy, however, does not provide guidance for the naming of park facilities that do not fall under these criteria.

Parks where naming rights funds have not been secured should be approached with deliberation and the City Council should designate the names of parks and recreation facilities. The City Council would ideally make its selection in this case after receiving a recommendation from a park naming committee consisting of three (3) members of the Parks, Recreation and Cultural Services Commission, two (2) members of the Historical Commission and two (2) youth who reside in the surrounding neighborhood as appointed by the Director of Parks, Recreation and Cultural Services.

In efforts to engage the community, the committee will, if council approves, under the direction of the Parks, Recreation, and Cultural Services Department, conduct a community-wide solicitation for naming the park based on the following guidelines:

- Neighborhood or geographical identification
- Natural or geological feature
- Historical or cultural significance
- No site shall be given the same name as an existing public facility or school site

Due to the DNR policy discouraging the naming of parks after individuals, we will not include that option among the guidelines. MDNR policy states:

The Michigan Natural Resources Trust Fund Board will not assist in any acquisition or development project where the site will be named in honor of a person either living or deceased. Funding recipients may ask the MNRTF Board for a waiver to this policy when they propose to name the site after an individual or organization that has made a

significant financial contribution (including donation of land value) toward completion of the MNRTF project.

The department of Parks, Recreation and Cultural Services will work with the parks naming committee to complete the public input stage of the park naming process by February 13, 2012. A recommendation from the park naming committee will be presented to City Council for their final selection by March 12, 2012.

**RECOMMENDED ACTION:** Approval of process to name parkland located at 13 Mile Rd and Old Novi Road (Landings Property).

The majority of the Landings park property was acquired by the City in the 1980's and was designated as parkland on March 22, 2010. The "Landings" name comes from a proposed development that at one time was planned to go in at that site. The current name does not reflect the rich and unique history of the property and another name should be considered.

Also, naming rights for fixed amount of time and onto the "official" name. Such as, ITC added to Community Sports Park for duration of naming rights agreement.

In 2005 the Novi City Council adopted the Parks and Recreation Facilities Naming Rights Policy, which provides the authorization for an individual, family, private business or corporation to purchase the right to name a fixed asset. The policy, however, does not provide guidance for the naming of park facilities that do not fall under these criteria.

Parks where naming rights funds have not been secured should be approached with deliberation and the City Council should designate the names of parks and recreation facilities. The City council should make its selection after receiving a recommendation from the Novi Parks, Recreation & Cultural Services Commission, which shall be based upon public input from individuals and organizations.

#### Common criteria for park naming:

- Neighborhood or geographical identification
- Natural or geological feature
- Historical or cultural significance
- A historical figure
- An individual who has made a significant land, monetary or civic contribution to the park system
- An individual who gave their life while serving in the United States of America in military service
- As required by purchase agreement

Following the selection of a park name the property or facility should be identified with appropriate signage and the name should remain for a designated number of years.
