

The City of Novi Planning Commission has begun the process of reviewing three Study Areas to consider amending the Future Land Use designations in the Master Plan for Land Use. The current Master Plan was adopted in 2004, and will be modified only where determined necessary and appropriate. A key element of the process is to gather community input regarding the future direction of the City in these areas.

### PLEASE JOIN US! - REFRESHMENTS PROVIDED!

The three areas (map on reverse) identified for study include:

Southwest Quadrant Study Area: Primarily at intersections in this area (generally 8 to 10 Mile Rd., Napier to Beck Rd). Recommended residential densities will also be considered.

I-96/Novi Road Study Area: Properties surrounding this key intersection. In the 2004 Plan, a large part of this Study Area was identified as "Downtown West."

Twelve Mile, Napier and Wixom Roads Study Area: Identified as a "Special Planning Project Area" in the 2004 Plan which requires further study to recommend the area's future land uses.
