**SUBJECT:** Approval of a Resolution to close Grand River Avenue from the Suburban Collection Showplace to 45200 Grand River Avenue for the 2022 Michigan State Fair 5K Run from 8:00 AM to 9:15 AM on Saturday, September 3, 2022.

**SUBMITTING DEPARTMENT:** Department of Public Works, Engineering Division

**BACKGROUND INFORMATION:**

The Suburban Collection Showplace is including a 5K Run as part of the Michigan State Fair on Saturday, September 3, 2022. The runners will leave the Suburban Collection Showplace campus at 8:00 AM and will proceed east on Grand River Avenue to Taft Road, north on Taft Road to the end of the road, turn around and head back north to Grand River Avenue, east on Grand River Avenue to 45200 Grand River Avenue, turn around and head back west on Grand River Avenue ending at the Suburban Collection Showplace at 9:15 AM. They are requesting to close the two westbound lanes of Grand River Avenue and Taft Road, north of Grand River Avenue, during this timeframe.

The Road Commission for Oakland County (RCOC) has issued an Annual Permit Number 61758 (that is valid through December 31, 2023) to the City allowing use of the roadways under County jurisdiction for civic events. The permit is predicated upon the adoption of an Authorizing Resolution by the Novi City Council approving the event and agreeing to the terms of the permit. Permit requirements include hold harmless and indemnity and represents the Board of Road Commissioners against any and all claims for bodily injury or property damage, or any other claim related to the event.

Grand River Ave is under the jurisdiction of the RCOC. Approval of the attached resolution is required as part of RCOC Permit Number 61758.

**RECOMMENDED ACTION:** Approval of a Resolution to close Grand River Avenue from the Suburban Collection Showplace to 45200 Grand River Avenue for the 2022 Michigan State Fair 5K Run from 8:00 AM to 9:15 AM on Saturday, September 3, 2022.

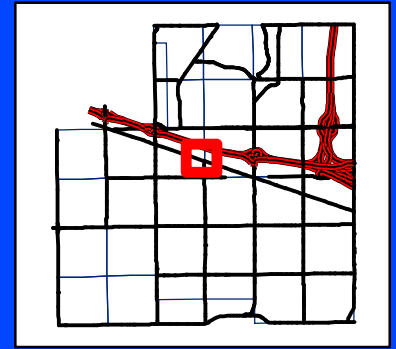


Enclosed is your annual permit for community events such as parades, banners, festivals, and block parties, on roads under the jurisdiction of the Road Commission for Oakland County. This permit is valid through December 31, 2023.

This permit allows communities to conduct community events or install banners under the following conditions:

1. That the local municipality adopts a resolution authorizing the event or banner.
2. That a copy of the resolution is provided to the Road Commission, via email to [permits@rcoc.org](mailto:permits@rcoc.org) or facsimile at (248) 858-4773, a minimum of three (3) days prior to the event or installation of the banner.
3. That the local municipality is responsible for necessary or appropriate traffic control associated with the event.
4. That any banner be installed above minimum height and clearance requirements. Specifications for permitted banners are enclosed.
5. That the municipality records the 5-digit permit number on all event-related documents/resolutions when submitted for review.
