SUBJECT: Approval of Traffic Control Orders 16-21 through 16-25 for the existing and proposed No Parking Signs at the intersection of Arcadia and Cordoba.

BACKGROUND INFORMATION:

The City's Engineering Division received a request from a resident near the intersection of Arcadia and Cordoba in Walden Woods Subdivision to install a new no stopping, standing, or parking sign at the northwest corner of the intersection. There are existing no stopping, standing or parking signs on all three legs of the intersection except the northwest corner. In reviewing the traffic control orders for the existing signs, it was determined that the traffic control orders do not match the signs that exist in the field and that some of the signs were not covered by traffic control orders. The original intent of the signage was to keep the intersection clear of stopped vehicles to improve intersection safety for pedestrians walking to school.

The proposed traffic control orders match the existing signage prohibiting stopping, standing and parking at all times (instead of the hours in the old traffic control orders) and extend the zone to the northwest corner of the intersection as requested.

Traffic control orders are required by the Uniform Traffic Code (adopted by Section 33-51 of the Novi Ordinance) to enforce traffic control signs that have been installed on public streets. The table below summarizes the traffic control orders that were prepared by the traffic engineering for consideration by City Council.

TCO No.	Description
16-21	Rescind TCO 00-38, 00-39, and 00-42
16-22	No Stopping, Standing or Parking on Northbound Arcadia from 80 feet south of Cordoba to a point 120 feet north of Cordoba.
16-23	No Stopping, Standing or Parking on Southbound Arcadia from 120 feet north of Cordoba to a point 130 feet south of Cordoba.
16-24	No Stopping, Standing or Parking on Eastbound Cordoba from 90 feet west of Arcadia to the intersection at Arcadia
16-25	No Stopping, Standing or Parking on Westbound Cordoba from Arcadia to a point 90 feet west of Arcadia.

Upon approval of the traffic control orders, the new signs will be scheduled for installation by DPS' Field Operations Division. The proposed changes have been communicated with the Walden Woods Homeowners Association.

RECOMMENDED ACTION: Approval of Traffic Control Orders 16-21 through 16-25 for the existing and proposed No Parking Signs at the intersection of Arcadia and Cordoba.

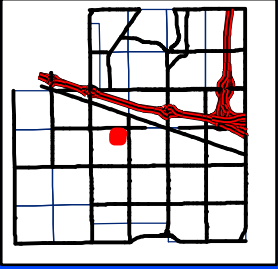

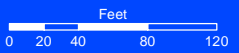
