SUBJECT: Approval to procure a Husqvarna, Model FS 5000 D – 30 ET, Concrete Cutting Saw and factory installed 5th wheel kit, from Cougar Sales and Rental, Inc., the low bidder, in the amount of \$25,574.95.

BACKGROUND INFORMATION:

The Novi City Council approved funding for the purchase of a replacement Concrete Cutting Saw in the fiscal year 2016-2017. Procurement of a replacement saw provides DPS staff members the ability to perform effective and efficient concrete roadway repairs, enhancing service provided to our residents.

A replacement unit decreases down time associated with mechanical repairs, and improves cutting quality, needed to properly remove and replace concrete. The machine is used to perform routine maintenance on storm basins, broken roadway panels, curb sections and damaged non-motorized assets.

On March 9, 2017 following a public bid solicitation period, nine bids were received. Upon a thorough evaluation, DPS staff determined that Cougar Sales and Rental, Inc. met all specifications by providing a responsive bid on the Husqvarna FS 5000 D – 30 ET concrete cutting saw and factory installed 5th wheel kit (image attached).

Delivery will take place in 7-10 days following the approval of the purchase.
