**SUBJECT:** Approval of Resolution authorizing submission of a Michigan Council of Art and Cultural Affairs (MCACA) Capital Improvement Program grant application for \$100,000 to enhance the Villa Barr Art Park property.

**BACKGROUND INFORMATION:**

Parks, Recreation and Cultural Services (PRCS) has a goal of maximizing opportunities for the Villa Barr Art Park property in the 2015-19 Strategic Community Recreation and Master Park Plan. In addition, City Council has supported opening the Villa Barr Art Park to the public through approval of a FY 17-18 CIP project that will add a paved bus loop, parking spaces and pathways on the property. The total amount budgeted for the project is \$299,344.

PRCS has the opportunity to apply for a Michigan Council of Art and Cultural Affairs (MCACA) Capital Improvement Program grant to assist with funding of the project and provide for future enhancements such as signage and park amenities.

PRCS can apply for up to \$100,000 in grant funding. The grant requires a 1:1 match. As the project has already been budgeted and approved, approval to submit the grant application will not require any further allocation of dollars. PRCS is required to submit the grant by June 1, 2017. If selected for funding by the MCACA in September 2017, the project must be completed between October 1, 2017, and September 30, 2018.
