

## PUBLIC MEETING IS APRIL 29 FOR PLANNED 12 MILE IMPROVEMENTS, BECK TO NOVI

The Road Commission for Oakland County (RCOC), in partnership with the cities of Novi and Wixom, will conduct a public meeting Tuesday, April 29, about planned 2026 through 2028 improvements to 12 Mile Road between Beck and Novi roads.


### MEETING DETAILS

- The meeting will take place Tuesday, April 29, from 4 p.m. to 7 p.m.
- It will take place at the City of Novi Firearms Training Center, 26350 Lee BeGole Drive (on the north side of 11 Mile Road west of Meadowbrook Road, north of the Novi Department of Public Works Building).
- The meeting will be open-house format with no formal presentation. RCOC staff will be present to answer questions throughout the meeting.
- Large maps and diagrams of the planned improvements, including preliminary right of way acquisition plans, will be available for public review.

### ROAD IMPROVEMENTS

The improvements will include:

- Widening 12 Mile Road between Beck and Dixon roads to a four-lane boulevard including pedestrian facilities on both sides of the road.
- Removing and replacing pavement between Dixon and Novi roads
- Installing a 10-foot-wide sidewalk on the north side of 12 Mile Road and a 6-foot-wide sidewalk on the south side, excluding at the CSX railroad crossing. The sidewalks at the railroad crossing will be five-foot wide on both the north and south sides of 12 Mile Road.
- Improving the curve on 12 Mile Road east of Beck Road.
- Improving drainage throughout the corridor.
- Updating the CSX railroad crossing.
- Replacing several large culverts under the road.
- Replacing traffic signals throughout the corridor.



- constructing an additional southbound lane on Beck Road at the 12 Mile intersection.
- Realigning the Taft Road/12 Mile Road intersection.
- Reconstructing the West Park Road/12 Mile Road intersection and adding dual right-turn lanes from West Park to 12 Mile.

### IMPACT ON TRAFFIC

There will be intermittent lane closures during utility relocation and tree removal, and flaggers will direct traffic during these operations. During road construction, there will be periods where the road is completely closed and others where a single lane is maintained in each direction.

### PROJECT SCHEDULE & COST

Site preparation work and utility relocation will take place starting in 2026. Tree removal will take place in the winter of 2026-27. Road work will take place from the spring of 2027 through the fall of 2028.

The project will cost \$35 million and will be funded with a mix of federal funds and contributions from RCOC, the City of Novi, the City of Wixom and Oakland County general government (through the Tri-Party Program).
