I'm not aware of any plans to repave the roads.

We've looked at doing the sidewalk on the south side of 10 Mile before but it's not a near term priority because of the number of easements it would require and landscaping/obstacles. I can add it to the next Mobility Committee agenda to discuss, we will be working on re-prioritizing sidewalk segments with the committee this year.

Alternatively, if residents and/or the HOA were willing to grant a sidewalk easement, a connection could be made within the subdivision, in between houses.

2. Sidewalk connection to ITC Trail. Not only do they not have sidewalks in their neighborhood, but they also lamented not having access to ITC Trail to the west. Is there any plan to continue the sidewalk on the southside of 10 Mile to the trail?
