SUBJECT: Approval of Traffic Control Orders 16-33 through 16-49 for Valencia Circle located within Valencia Estates.

BACKGROUND INFORMATION:

The acceptance of the street within Valencia Estates is being presented for City Council consideration elsewhere on this agenda. The approved site plan for the development includes the installation of traffic control devices, such as stop signs within the subdivision.

Traffic control orders are required under the Uniform Traffic Code to enforce traffic control signs that have been installed on public streets. Therefore, staff has reviewed the installation of the traffic control signs and has prepared the following traffic control orders for approval by City Council.

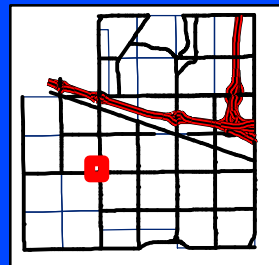
