SUBJECT: Approval of proposed park shelter rental rate increase to begin on January 1, 2027.

SUBMITTING DEPARTMENT: Parks, Recreation & Cultural Services

KEY HIGHLIGHTS:

- Rates have remained the same since 2021
- The PRCS Commission moved to bring the proposed rates below to Council for approval
- Non-residents are proposed to be charged 50% above resident rates

BACKGROUND INFORMATION:

City ordinance (Sec. 25-67 (Ord. No. 83-113, §11.01, 7-11-83.) requires rates for the use of Lakeshore Park facilities be prescribed by City Council resolution. Consistent with past practice, staff is proposing increases to all park shelter rental rates.

Factors considered in establishing the proposed rates include amenities, location, demand, staff and supply fees, and comparisons with rates charged by other communities. At the August 20, 2026 Parks, Recreation and Cultural Services Commission meeting, members recommended that non-resident rates be set higher; therefore, the proposed rates include an additional 50% for non-resident rentals, with rates rounded as appropriate. For summer 2026, 93% of Lakeshore Park shelter reservations to date have been made by residents.

Proposed increases are indicated in red.
