SUBJECT: Approval to award a construction services contract to Ferguson Waterworks for the replacement of 278 water meters, in the amount of \$285,208.

BACKGROUND INFORMATION:

The Department of Public Services' Water and Sewer Division is beginning a meter replacement program to exchange aging and likely inaccurate meters, which are under registering water usage. Using a tool called SEER (Statistical Evaluation for the Enhancement of Revenue); Ferguson Waterworks identified 278 of the City's 14,500 meters for replacement in this first phase of meter replacements. These meters generally consist of the City's high volume water users with older meters, since these meters have the highest potential for being significant contributors to the City's non-revenue water loss (unmetered water used by a customer). The SEER process factors in meter type, size, age, and predicted accuracy to prioritize a list of replacements. Since the loss of revenue can be significant, the return on investment (ROI) for these meters can be a very short time. For this first phase of replacements, the estimated ROI is 1.26 years (see Ferguson Waterworks' proposal for additional details).

This meter replacement program was approved in the Capital Improvement Program as Phase 2 of the Advanced Metering Infrastructure project (WTS018). This will be the first phase of a multi-year project with an anticipated completion between now and FY 2020-21. The result will be replacement of the entire log of aging meters and other meters considered contributors to the City's non-revenue water loss.

Ferguson Waterworks provided the enclosed proposal to complete the meter replacements. Ferguson Waterworks is the sole distributor of Neptune water meters in the state of Michigan and supplies the water meters purchased by the City. The attached proposal was provided project completion, and pricing for the equipment and installation is based on the Oakland County Cooperative Purchasing Contract (see attached Contract and Price List).

RECOMMENDED ACTION: Approval to award a construction services contract to Ferguson Waterworks for the replacement of 278 water meters, in the amount of \$285,208.

Dear Mr. Croy,

It has been a pleasure working with the City of Novi to evaluate the status of the City's metering system. We are happy to present the following proposal for phase one of the City's commercial meter replacement program.

Project Overview and Methodology:

Ferguson Waterworks (formally Michigan Meter Technology Group) has been the City of Novi's water meter provider for several years. Ferguson is a level one distributor of Neptune water meters and metering equipment. We also employ a larger meter service team that installs, tests, and repairs commercial water meters. Recently, we have been working with the City of Novi to develop a strategy to begin a phased commercial meter replacement program. We used a tool provided by Neptune Technology Group called SEER (Statistical Evaluation for the Enhancement of Revenue) to evaluate the City's commercial meters. While performing tests across the country on several brands, types of meters, and metering technologies, Neptune's service group gathered the results of more than 10,000 individual meter tests into a relational database. This data is now used to evaluate the life of meters in service by comparing similar variables through a multiple regression analysis. The concept is simple, as meters age or are subjected to heavy usage they lose accuracy, which leads to less water being billed by the City, which leads to an increase in unaccounted for water, which ultimately leads to a loss in revenue. SEER is designed to take an analytic approach to analyzing the state of a utility's meter infrastructure by comparing archival data to existing meters. Specifically, SEER looks at the following variables of each meter in the evaluation:

1. Account Number
2. Customer Name
3. Address
4. Meter Serial Number
5. Meter Size
6. Meter Type
7. Meter Manufacturer
8. Meter Age
9. Annual Revenue
10. Replacement Cost

Comparing these inputs to the existing Neptune SEER database, the following outputs are generated:


1. A predicted meter accuracy
2. Revenue in years
3. Payback in years (ROI)

Using this methodology, we extracted the needed inputs from the City of Novi's utility billing system, BS&A. SEER was run on every meter in the City of Novi's metering system at no cost to the City. The overall goal is to set a priority list for proactive meter replacement to enhance the City's revenue stream. The following is a summation of the results from the analysis.

SEER Results

The City of Novi's metering system consists of roughly 14,363 meters ranging in size from 5/8 inch through 8 inch. The metering system generates roughly \$21.66 million in revenue for the City. Once we reviewed the results for the City's overall metering system, we turned our attention toward the City's commercial meters: Meters two inches and larger were analyzed and the results are as follows:

- 961 total meters, annual revenue generation of \$6.532 million
 - 6.6% of the City's meters generate 30.1% of the City's water related revenue.
- Average meter age was 12.53 years, with the oldest meter being recorded at 37 years
- Complete replacement of all meters in the commercial system is estimated to cost \$1,085,612.75
- Replacement commercial meters would generate an estimated \$350,915.11 in annual revenue gain
- Total predicted payback in years (ROI) is 3.09 years



Recommendation:

Based off the SEER results we are now able to sort the database by several variables to evaluate different options. For our purposes, we worked to establish a proactive priority list, whereby we identify the meters that will generate the quickest payback for the City based on its budget for this phase. Therefore, we sorted all 962 meters by "payback in years" (ROI) and identified 278 meters that we recommend be addressed within this phase.

- Total cost of Phase One: \$285,207.84
- Total predicted revenue gain: \$225,084.37
- Total predicted payback in years (ROI) is estimated at 1.26 years



Please note, all pricing provided for this project is provided through the Oakland County Water Resources Commissioner's Office Cooperative Contract, including installation.
